## *Accounting MOVE Project process*

Shortly after you start the survey, we will contact you to start the interview process. Typically, we interview the key MOVE contact – usually, a human resources or talent development manager – to understand your firm’s history and culture regarding the advancement of women.

We also are on the lookout for great case studies and compelling personal narratives to showcase in MOVE reports, webinars, and media mentions. If we detect one at your firm, we will request additional interviews.

You may be wondering which is best for your firm: the Snapshot or the comprehensive Scorecard. Choose the Scorecard if:

- You want detailed insights that compare your firm’s culture and programs to those of firms of comparable size and growth stage
- You want examples of programs and practices from MOVE Best Accounting Firms for Women
- You need additional context for setting priorities for resources and budget
- You want to ensure that your women’s initiatives equip your firm with a competitive advantage
